The following are however specially brought to your kind attention:

1. The school shall appoint only qualified and eligible staff.
2. Service agreement be executed with the staff as per norms generally accepted by State Government. A copy of the same be sent to the Board.
3. Service conditions, Pay and allowances and other benefits to the employees of the school shall in no way be less than corresponding salaries of employees working in Government schools of the State concerned.
4. The school will help the Board in the smooth conduct of the examinations by placing the necessary staff & accommodation i.e. Halls, Rooms available in the school premises and furniture at its disposal for holding its examinations free of charge, if required to do so.
5. The school shall remit Rs.100/- as Annual fee regularly by 31st March each year. A copy of the prescribed form for the same is also enclosed.
6. The school and its records shall be open for inspection by an official of the Board or any person authorised by the Board or the State Education Department at any time and the school shall furnish information as may be asked for by the Board or State Govt. from time to time.

7. The rate of tuition and other fees charged shall commensurate with the facilities provided.
8. The admission to the school shall be open to all without any discrimination on the ground of religion, caste or race, place of birth or any of them.
9. No unrecognised classes/branches shall be run within the premises of the school or outside in same name of school.

The school shall provide adequate curricular and extra-curricular activities for the wholesome development of students.

The Code No. allotted to your school is 21371. This may please be noted and quoted for any correspondence with the Affiliation Branch of the Board.

Your attention is also drawn to the specific conditions, pointed out by the Inspection Committee, ~~as detailed during the~~ ~~XXXXXXXXXXXX~~ ~~XXXXXXXXXXXX~~ by the Board, which are given below:-

1. The staff of the school be paid pay and all other allowances atleast at par with the State Govt. with immediate effect, and annual increment in the grade.
2. The strength of ~~the school~~ ^{each section} be restricted to a maximum of 40 students.
- 3.- Two separate accounts namely 'school fund Account' and 'pupils fund Account' be operated in the school.
4. The staff of the school be confirmed after the probation period. On confirmation they shall be allowed the benefit of contributory Provident fund, gratuity etc.

 - i. Boundary Wall: Concrete boundary wall of not less than 6 ft. height, enclosing the school campus/site. Composite boundary walls which are partly concrete and partly grill/mesh/barbed wire below 6 feet will not be acceptable. If fencing/grill is required, then the same should be over and above 6 feet height.

If the compliance is not submitted within the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
